### Memorial to Fallen Detective Coming...Eventually

A freeway sign dedicated to police Lt. Curtis Massey, who was killed by a drunk driver, is in limbo as the city waits for an invoice from Caltrans.


A memorial to fallen Culver City detective Lt. Curtis Massey remains in limbo while city officials wait for Caltrans to send them an invoice for the sign, which will be posted on the 10 freeway near where Massey was killed in January 2009.

"Things at Caltrans don't move too quickly," said Shelly Wolfberg, assistant to Culver City Manager John Nachbar. Wolfberg is the city staff member who has been working with the police department and others to get the freeway sign for Massey.

According to Assistant Chief of Police Scott Bix by, the campaign to get the sign for Massey began during the summer after Massey's death.

"The freeway just seemed like an appropriate way to mark that spot," Bixby said.

Massey was driving to work early in the morning of Jan. 28, 2009, on the eastbound 10 freeway when his car was struck by a drunk driver going against traffic. The other driver also died in the accident.



"By making his name a part of our landscape, we hope to honor Lt. Massey, an indelible part of our city," Bass said in her remarks before the council.

"This is an incredible honor in Curt's memory, to me and to Curt's family," said Melody Massey, the lieutenant's widow. "I have no idea what it took to make this happen, but thank you, thank you."

Massey supervised the police department's juvenile section; in fact, Bixby said he was the kind of officer who went above and beyond the call of duty, citing an example when Massey drove all over the city with a young witness to capture child predators. Bass noted in her presentation that Massey spent many hours working as a volunteer to keep kids out of trouble.

"He was just a great guy," Bixby said.

Wolfberg said there doesn't seem to be a timeline in place for when the city will receive the invoice, nor does she know what dollar amount it will show. Attempts on the part of Patch to find out from Caltrans directly did not elicit a response.

"When I hear something, I will let you know," Wolfberg wrote in an e-mail to Patch.
